1. Definitions

3. Eligibility & Conditions

- a) Referee must be a new customer (not an existing or returning BHIVE Member). Subject to discretion of BHIVE, all referrals are valid only once received on the referral form available at https://bhiveworkspace.com/refer-a-space/ ("Referral")
- b) Rewards are applicable only upon successful execution of the Membership Service Agreement between Referee and BHIVE with a minimum 12-month lock-in period as illustrated in Annexure A-1. In case of execution of the Membership Service Agreement with a lock-in period less than 12 months, Referrer may be eligible for pro-rata rewards as per the illustration in the table in Annexure A-2.
- c) In case the Referrer is a BHIVE Member, then the Referrer must be an active BHIVE Member at the time of the reward applicability to be eligible for the reward as per Clause 2(a) of this Policy.
- d) In case of multiple referrals by more than one Referrer for one New Customer received to BHIVE, the first valid submission of the referral form will be considered by BHIVE. In case of simultaneous referrals, the Referee's inputs may be taken by BHIVE to decide the eligible



Referrer, and in any case, the decision will be at the sole discretion of BHIVE and shall be final and binding.

e) For the Referee, Rewards are processed subject to execution and adherence to the Membership Service Agreement, their first full-month invoice is generated and cleared, and all invoices prior to the reward are cleared. For the Referrer, the Reward shall be processed subject to execution and adherence to the agreement with BHIVE, if any, in the same month in which the reward is provided to the Referee, subject to clearance of all past invoices by the Referrer, if any.

4. General Terms

- a) Discounts and rewards apply only to the membership fee, excluding security deposits, applicable taxes and ancillary charges.
- b) BHIVE reserves the right to modify or terminate any part or whole of the Referral Policy at any time without prior notice. Any and all decisions shall be at the sole discretion of BHIVE and shall be binding on all parties.
- c) All payments/rewards are subject to applicable taxes, including TDS as per Indian law.
- d) BHIVE reserves the absolute right at its sole discretion to vary, delete, add or amend any of the terms and conditions and further withdraw the entire scheme without any prior notice.
